Adult Ed – Laura Williams gave an overview of the programs and services offered: Middle College, ESL, GED/HiSET tests, HSE classes, and new instructor for ESL

SOS/Literacy – Brandice Connor gave an overview of the Reader's Route program, distributed flyers (IN NEED OF TUTORS), shared success stories from clients that received tutoring, and discussed some of the complications of the tutoring program at the prison (segregation & transfers).

C.N.A. – Susie Landers gave and overview of the registration process – need at least an 8th grade math skill level / 85% on the math placement test. Also, she mentioned that based on demand we may or may not offer the program again at Pleasant Meadows.

Agenda item: Partner Share

Discussion:

Dick Brazda is in need of volunteers to help offer tax assistance.

Brian Hensgen gave an overview of AJC and their federal guidelines.

Jeri Spezia shared that there is a list of resources listed on Vermilion County's website for mental health, and that the Vermilion County Mental Health 708 Board is offering FREE individual and group mental health first aid training.

Jonathan Jett gave an overview of Vermilion County Works, the Industrial Career Pathways Program and the Out-of-School Youth Program for ages 16-24.

Cheryl Reifsteck shared about the ROE's new regional state school supplementary GED prep classes (HSE Alternative Credentialing System) that allows those who left high school a few credits/classes shy of graduating can complete those specific courses/credits to receive their high school diploma. This program also allows students to take the GED/HiSET early at the age of 16. Pilot program takes off in January 2019 only at the ROE and will have a cost associated.

Resources:

The American Job Center offers financial assistance for the GED/HiSET test costs, C.N.A., childcare and more. The AJC also offers career counselling and assist in building resumes and cover letters.

East Central Community Action offers financial assistance for the GED/HiSET test costs, C.N.A. scholarships, and financial assistance for energy bills for families with children under the age of 5 and seniors 60 years old and older.

Kenneth D. Bailey Academy offers a 2nd chance program for youth that includes counselling and assistance in navigating life after high school.

Dick Brazda offers tutoring and free tax assistance for household that make less than \$55,000.
