Explained the request from Dean Dittmar, Agricultural Education, FCAE, in regard to ag classes offered online, that might be available for students in high schools without an ag program.

Some concern about ag students taking certain courses online because of the hands on skills required.

Questioned the mix of College express/ college students/ online students.

Recommended that Ag Sales be added to the curriculum.

It was pointed out that the current curriculum does include a sales course from the business department.

4. Discussion of Sustainable Agriculture curriculum

Food science - Requires too much equipment and new faculty. Not feasible.

5. Discussion of Ag Club equipment for land lab use

Mr. Potter gave an update of the purchased equipment and announced that it would be desirable for the Ag Club or Ag Department to own a disk and planter. It was recommended that Mr. Potter talk with Mowrey Auction Company,

Milford Illinois. It was also recommended that Mr. Potter donate his old equipment. It was established that it was too large, however. The purchasing process was discussed because it adds to the difficulty of purchasing equipment at an auction.
