#### Welcome:

Dr. Nacco welcomed and thanked all for their input for the program.

Director Skinner introduced everyone else in attendance.

## **Clinical affiliation Updates:**

Carle: Amber Nibling reported that the Carle Nurse Residency Program is now accredited.

OSF Danville and Urbana: The buy-out of Presence has opened up doors for more clinical sites. They are reaching out to us for more involvement.

VA: We have expanded our clinicals; this past summer the part time cohort went to the VA for Mental Health. Wexford Health: Students go to the prison for clinical observations.

## Nursing Program Updates

## **Cohort Student Numbers**

- Cohort 1218 PT LPN-RN 6
- Cohort 0519 32
- Cohort 1219 15
- Cohort 0520 35

### New Requirements Fall 2019

- In Fall 2019 all general educations courses will now be prerequisites completed with a C or better. (Survey of Statistics can must be completed before start of 2<sup>nd</sup> year nursing)
- Also, recommended GPA will now be a required Minimum GPA 2.5

#### Simulation Education

Sim lab is expanding.

- State board of nursing allows a maximum of 25% of clinical to be simulation. We will have 2 clinical simulations in NURS 192 and 1 clinical simulation the other nursing courses. This is under the state maximum due to adequate clinical opportunities.
- Per Laerdal's recommendation; we have hired sim techs and will have a task force to work on improving/implementing clinical simulation.
- We plan to work with Medical Imaging and Health Information Tech for inter-disciplinary involvement.

## ACEN Reaccreditation Fall 2018 Preliminary results

- Fully compliance in all Standards
- Several small areas that need development
- Final report will be released in Spring 2019

Pass Rates – First time test takers (Expected Level of Achievement (ELA) 75%)

- 1217 cohort 92% (25 of 27 passed)
- 0518 cohort 80% (19 of 24 passed)

Completion Rate (ELA 65% will complete the program within 6 semesters)

- 2018 = 60% We lost a lot early in the program. We had a special meeting with the students that left and received valuable input. Changes were made as a result of that information.
- 2017 = 80%
- 2016 = 95%
- 2015 = 89%

Employment Rate (ELA 80% of the graduate will have a job in nursing within six months after graduation)

- 2017 = 100% (29 surveys distributed, 28 returned)
- 2016 = 100% (70 surveys distributed, 63 returned)
- 2015 = 100% (36 surveys distributed, 9 returned)

# **Brain Storming Session**

This was a vigorous breakout activity with each table offering their ideas via a SWOT-type analysis of the Nursing Program

#### What do we do well?

• Incorporate ATI better with med sheets

- Wants us to succeed and is willing to help
- Asks for student input/is fair
- Helps with wading through large amounts of material
- Accept Feedback from community
- Professionalism
- Faculty display professionalism with students. Good role modeling expected of the students
- Streamline VA Process for New students
- New student orientation
- Requiring pre-requisites now
- 8 week pre-requisites courses
- Strategies to improve pass rates
- Prep for ACEN site visit
- Good clinical prep

#### What can we do better?

- Admission interview-informal or letters of recommendations
- Expand clinical sites More patient's, more hands on, checklists, ambulance ride, ER, urgent care experiences
- Increase diverse clinical opportunities (nights and weekends)
- Have Case studies for each unit (Med-Surg)
- More clinical simulation experience related to each unit
- Reviewing/test feedback on information people missed
- Incorporate more ATI into classroom learning
- Preceptor opportunities with nurses in clinical settings for consistency
- Stress importance of bedside nursing
- Revamp the skills labs (timing, long, skills check off sheets)
- Sim Lab (evaluate by students)
- Peer mentoring
- Communicate official changes to program to advisors sooner
- Applications develop report
- Define GPA in regards to application. Do we want cumulative or Prerequisite only course GPA?
- Why aren't students completing?
- Focus on consistent pass rates
- Focus on consistent completion rates
- Expand knowledge and partnership with WIOA
- Collaborate with CNA Program

#### What should we keep on doing?

- Helping us learn how to critically think, priority care
- Making clinicals feel like a safe learning environment
- Black Board modules
- Keep working with community and clinical partners
- Required General Education courses
- Receiving community input
- Sim Lab/utilization

Add to Course description that students are qualified to sit for CNA test after successfully completing NURS 192

Health Department would like for students to help put on a Flu Clinic next Fall

Health Department will be doing a full scale disaster drill and need student involvement.
