The meeting was called to order by Chair Fauver at 8:00am.

Action Items:

Vermilion County Works recommended approval of three youth providers for the 2016-2017 year round program. These providers include the YMCA, East Central Illinois Community Action Agency, and First Institute. Motion to approve Vermilion County Works' recommendation was made by John, seconded by Todd. No opposed, motion carried.

After several attempts to collect a recent audit from East Central Illinois Community Action Agency, it was recommended by the Accountability Committee to decline funding for this program. The YMCA will be funded at \$115,116 to serve thirteen (13) NEW out of school youth and thirty (30) existing in school youth. First Institute will be funded at \$209,884 to serve twenty-four (24) youth. Motion to approve allocations as presented was made by John, seconded by Randy Johnson. Dr. Jacobs and Laura Williams abstained. No opposed, motion carried.

In transition from WIA to WIOA, there has been some minor change to the bylaws. Chair Fauver requests changing the bylaws to state the annual meeting will be in May, not November. Motion to approve the revised bylaws with this amendment was made by Todd, seconded by Kathie. No opposed, motion carried.

Executive Committee had nothing additional to report.

Brian gave a brief update on the Vermilion County Works budget. He stated under WIOA, we are expected to see a 5% increase annually.

No reports were heard from Workforce Solutions Committee, Board Development Committee, and Youth Services Committee.

Mike Marron, CEO and Vermilion County Board Chairman gave a brief update on VC2025.

Laura Williams gave a brief update to GED testing and stated testing is half off with a code for a limited time.
